Procedure for Magnet School/Magnet Program Transfer Request

Starting January 23, 2014, parents can obtain the Magnet School/Program Application and Transfer Form from the following locations: JPPSS website, jpschools.org, each magnet school's website, the Compliance Office, 501 Manhattan Blvd., Suite 1100, Harvey, (504) 365-5312 from 8:30-4:00, or at the magnet school site from 9:00-2:00 (January 24, 2014).

1. Parents must hand deliver completed forms to the magnet school to which they are requesting enrollment between January 24, 2014 and June 3, 2014.
2. A Magnet School Transfer Form must be submitted with each application.
3. For IB programs, the principals will contact parents regarding an appointment and will subsequently approve or deny request based on the criteria outlined in the Frequently Asked Questions page.
4. The Compliance Office will give final approval or denial of the transfer request based on (a) the principal's approval or denial, (b) capacity of each grade level at each school, (c) applicant meeting criteria as described in *Frequently Asked Questions #4*, and (d) the general guidelines set forth in the Final Settlement Agreement. The Compliance Office will inform the principal and the parent of the decision.
5. New applications and transfer requests must be submitted at each new organizational level magnet school (middle school and again at high school).
