Criteria for Magnet School/Magnet Program Transfers

- By submitting this transfer request form, the school system's Compliance Officer will be able to provide evidence to the Court as to why such students are attending a school not located in his/her attendance zone. Students who were previously approved in 2013-2014 to attend a magnet school or magnet program and wish to continue enrollment for the 2014-2015 school year at that same magnet school **DO NOT NEED TO SUBMIT** a magnet school transfer form.
- Transfers for students in grades kindergarten through seven shall be made at least 30 days prior to the commencement of a school year or, where permitted by a particular magnet program with sufficient grade level capacity to accept a transferring magnet student, at least 30 days prior to the beginning of the second semester of a school year. Students in grades 8 through 12 seeking enrollment in a magnet school shall submit the appropriate transfer form at least 30 days prior to the commencement of a school year. Students entering into the school system for the first time may seek enrollment in a magnet school upon entering into the School System from another school district or from a private or home school situated within the Parish of Jefferson where such in-term enrollment is permitted by a magnet program and neither grade level nor school overcrowding will result.
